1. Your Acceptance

A. By using and/or visiting this website (collectively, including all Content available through the TravelTipsAndTours.com domain name (the "Website"), you signify your agreement to (1) these terms and conditions (the "Terms of Use"), (2) TravelTipsAndTours' privacy notice, found at <http://www.TravelTipsAndTours.com/privacy> and incorporated here by reference. If you do not agree to any of these terms or the TravelTipsAndTours privacy notice, please do not use the TravelTipsAndTours Website.

B. Although we may attempt to notify you when major changes are made to these Terms of Use, you should periodically review the most up-to-date version <http://www.TravelTipsAndTours.com/terms>. TravelTipsAndTours may, in its sole discretion, modify or revise these Terms of Use and policies at any time, and you agree to be bound by such modifications or revisions. Nothing in this Agreement shall be deemed to confer any third-party rights or benefits.

2. TravelTipsAndTours Website

A. These Terms of Use apply to all users of the TravelTipsAndTours Website, including users who are also contributors of video content, information, and other materials or services on the Website.

B. The TravelTipsAndTours Website may contain links to third party websites that are not owned or controlled by TravelTipsAndTours. TravelTipsAndTours has no control over, and assumes no responsibility for, the content, privacy policies, or practices of any third party websites. In addition, TravelTipsAndTours will not and cannot censor or edit the content of any third-party site. By using the Website, you expressly relieve TravelTipsAndTours from any and all liability arising from your use of any third-party website.

C. Accordingly, we encourage you to be aware when you leave the TravelTipsAndTours Website and to read the terms and conditions and privacy policy of each other website that you visit.

3. TravelTipsAndTours Accounts

A. In order to access some features of the Website, you will have to create a TravelTipsAndTours account. You may never use another's account without permission. When creating your account, you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You must notify TravelTipsAndTours immediately of any breach of security or unauthorized use of your account.

B. Although TravelTipsAndTours will not be liable for your losses caused by any unauthorized use of your account; you may be liable for the losses of TravelTipsAndTours or others due to such unauthorized use.

4. General Use of the Website -- Permissions and Restrictions

TravelTipsAndTours hereby grants you permission to access and use the Website as set forth in these Terms of Use, provided that:

A. You agree not to distribute in any medium any part of the Website, including but not limited to User Submissions (defined below) and downloaded Tours or other information, without TravelTipsAndTours' prior written authorization.

B. You agree not to alter or modify any part of the Website.

C. You agree not to access User Submissions (defined below) or TravelTipsAndTours Content through any technology or means other than the video/audio playback pages of the Website itself, or other explicitly authorized means

TravelTipsAndTours may designate.

D. You agree not to use the Website for any commercial use, without the prior written authorization of TravelTipsAndTours. Prohibited commercial uses include any of the following actions taken without TravelTipsAndTours ' express approval:

- use of the Website or its related services for the primary purpose of gaining advertising or subscription revenue except as expressly authorized below;

E. Prohibited commercial uses do not include:

- using TravelTipsAndTours pictures, audio/videos Tips or Electronic Postcards on an ad-enabled blog or website, provided the primary purpose of using them is not to gain advertising revenue or compete with TravelTipsAndTours;
- any use that TravelTipsAndTours expressly authorizes in writing.

F. You agree not to use or launch any automated system, including without limitation, "robots," "spiders," or "offline readers," that accesses the Website in a manner that sends more request messages to the TravelTipsAndTours servers in a given period of time than a human can reasonably produce in the same period by using a conventional on-line web browser. 5. Your Use of Content on the Site

In addition to the general restrictions above, the following restrictions and conditions apply specifically to your use of content on the TravelTipsAndTours Website.

A. B. You may access User Submissions solely:

- for your information and personal use;

- for Streaming. A. As a TravelTipsAndTours account holder you may submit travel-related and/or tour-related pictures, audio/video content ("User Videos") and textual content ("User Comments"). User Videos and User Comments are collectively referred to as "User Submissions." You understand that whether or not such User Submissions are published, TravelTipsAndTours does not guarantee any confidentiality with respect to any User Submissions.

B. You shall be solely responsible for your own User Submissions and the consequences of posting or publishing them. In connection with User Submissions, you affirm, represent, and/or warrant that: you own or have the necessary licenses, rights, consents, and permissions to use, and hereby authorize TravelTipsAndTours to use all patent, trademark, trade secret, copyright or other proprietary rights in and to any and all User Submissions to enable inclusion and use of the User Submissions in the manner contemplated by the Website and these Terms of Use.

C. For clarity, you retain all of your ownership rights in your User Submissions. However, by submitting User Submissions to TravelTipsAndTours, you hereby grant URaTrip LLC a worldwide, non-exclusive, royalty-free, sub-licensable and transferable license to use, reproduce, distribute, prepare derivative works of, display, and perform the User Submissions in

connection with the TravelTipsAndTours Website and TravelTipsAndTours ' (and its successors' and affiliates') business, including without limitation for promoting and redistributing part or all of the TravelTipsAndTours Website (and derivative works thereof) in any media formats and through any media channels. You also hereby grant each user of the TravelTipsAndTours Website a non-exclusive license to access your User Submissions through the Website, and to use, reproduce, distribute, display and perform such User Submissions as permitted through the functionality of the Website and under these Terms of Use. The above licenses granted by you in User Submissions terminate within a commercially reasonable time after you remove or delete your User Submission from the TravelTipsAndTours Service. You understand and agree, however, that TravelTipsAndTours may retain, but not display, distribute, or perform, server copies of User Submissions that have been removed or deleted. The above licenses granted by you in User Comments are perpetual and irrevocable.

D. We review all user-submitted content flagged as Inappropriate to determine whether it violates these Terms of Use—flagged content is not automatically taken down by the system. If we remove your submitted content after reviewing it, you can assume that we removed it purposefully, and you should take our warning notification seriously. If you find other user-submitted content on TravelTipsAndTours with the same violations, please flag them so we can review them as well!

- TravelTipsAndTours is for Travel Information and Tips, not for **pornography** or **sexually explicit content**. TravelTipsAndTours does not endorse any User Submission or any opinion, recommendation, or advice expressed therein, and TravelTipsAndTours expressly disclaims any and all liability in connection with User Submissions. TravelTipsAndTours does not permit copyright infringing activities and infringement of intellectual property rights on its Website, and TravelTipsAndTours will remove all Content and User Submissions if properly notified that such Content or User Submission infringes on another's intellectual property rights. TravelTipsAndTours reserves the right to remove Content and User Submissions without prior notice.

7. Account Termination Policy

A. Violations of the Terms of Use may result in a warning notification or may result in termination of your account and deletion of all your submissions. We decide whether we believe your violation of our Terms of Use should result in termination of your account. **If you have an account terminated you are prohibited from ever signing up for another account!**

B. TravelTipsAndTours reserves the right to decide whether Content or a User Submission is appropriate and complies with these Terms of Use for violations other than copyright infringement and violations of intellectual property law, such as, but

not limited to, pornography, obscene or defamatory material, or excessive size and/or length. TravelTipsAndTours may remove such User Submissions and/or terminate a User's access for uploading such material in violation of these Terms of Use at any time, without prior notice and at its sole discretion.

C. TravelTipsAndTours will terminate a User's access to its Website if, under appropriate circumstances, they are determined to be a repeat infringer.

8. Digital Millennium Copyright Act

A. If you are a copyright owner or an agent thereof and believe that any User Submission or other content infringes upon your copyrights, you may submit a notification pursuant to the Digital Millennium Copyright Act ("DMCA") by providing our Copyright Agent with the following information in writing (see 17 U.S.C 512(c)(3) for further detail):

- Information reasonably sufficient to permit the service provider to contact you, such as an address, telephone number, and, if available, an electronic mail;
- A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
- A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

B. Counter-Notice. If you believe that your User Submission that was removed (or to which access was disabled) is not infringing, or that you have the authorization from the copyright owner, the copyright owner's agent, or pursuant to the law, to post and use the content in your User Submission, you may send a counter-notice containing the following information to the Copyright Agent:

- Your physical or electronic signature;
- Identification of the content that has been removed or to which access has been disabled and the location at which the content appeared before it was removed or disabled;
- A statement that you have a good faith belief that the content was removed or disabled as a result of mistake or a misidentification of the content; and
- Your name, address, telephone number, and e-mail address, a statement that you consent to the jurisdiction of the federal court in Los Angeles, California, and a statement that you will accept service of process from the person who provided notification of the alleged infringement.

If a counter-notice is received by the Copyright Agent, TravelTipsAndTours may send a copy of the counter-notice to the original complaining party informing that person that it may replace the removed content or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider, member or user, the

removed content may be replaced, or access to it restored, in 10 to 14 business days or more after receipt of the counter-notice, at the sole discretion of TravelTipsAndTours.

9. Purchases

A. Pricing - TravelTipsAndTours reserve the right to change the price of any item offered for sale and/or related materials at any time.

B. Taxes - All prices are exclusive of sales taxes. Sales tax is applied as applicable.

C.
